



# Tow Services Agreement

**McCoy Towing LLC**, hereafter referred to as "**TOWING SERVICE**", who's physical and mailing address is **6555 S. Orange Avenue, Orlando, Florida 32809** and Choose an item. Referred to as "**PROPERTY REPRESENTATIVE**", **WHOSE ADDRESS IS** Choose an item. Hereby enter into the following agreement for the provisions of towing services and agree as follows:

The description and location of the property from which vehicles will be removed as, "Entire Property" located at Choose an item.

Trespass towing from the premises shall be authorized on the following day and times. **7 Days A Week 24 Hours A Day.** Any exceptions will be directly in writing and agreed upon by the parties before any changes are made.

All towed vehicles will be stored in a locked, gated impound lot located at **6555 S. Orange Ave Orlando, FL 32809.**

## **\*\* FEES CHARGED DIRECTLY TO VEHICLE OWNER ONLY**

Fees charged to a vehicle owner shall be consistent with applicable law, see paragraph 7 below. All fees to be charged at vehicle owner's expense and shall be as follows.

### **SCHEDULE OF FEES**

Trespass Tow Class A	\$125.00
Non-Consensual Class A	\$125.00
Non-Consensual Tow Mileage	\$3.00/mile
Non-Consensual Tow (beyond 30 minutes on scene)	\$31.25/per fifteen-minute block
Trespass/Non-Consensual Tow Storage (after initial non-fee period)	\$25.00/day
Research ownership of vehicle (unregistered vehicles)	\$5.00

**Notices**

- 1) Signs will be posted at each entrance and exit to the property and shall state as follows: **"TOW AWAY ZONE UNAUTHORIZED VEHICLES & VESSELS WILL BE TOWED AWAY AT THE OWNER'S EXPENSE 24 HRS A DAY 7 DAYS WEEK STRICTLY ENFORCED. STATUTE 715.07 "McCoy Towing 407-308-0088"**

**2) Contract Term**

This contract shall commence on Choose an item., and remain in effect for a period of one year. Contract can be renewed at the end of each year in month eleven for an additional year. **Initialed by Property Representative. \_\_\_\_\_**

**3) Termination**

Contract may be canceled at any time with a Choose an item.-day written notice delivered by certified US Mail by "Property Representative" and/or "Towing Service". While the Choose an item.-day notice is in effect no restrictions shall be put on the contract and no changes will be agreed upon unless in writing by the parties. The contract will remain in full force for the Choose an item.-day notice period.

**4) Trespass Towing**

By this Agreement, the **"Property Representative"** authorizes the **"Towing Service"** to remove any unauthorized vehicles, hereinafter referred to as **"trespass towing"** parked on the following property: Choose an item., hereinafter referred to as the **"premises"**.

- 5) Property Representative affirms that he/she is the owner or the tenant of the premises or the agent/authorized representative of the owner or tenant and has the authority to enter into this Agreement.

**6) Payment**

The Parties agree that all fees to be paid by the vehicle's owner or operator for the trespass tow shall be in accordance with the requirements of those ordinances and statutes set forth in paragraph 7 below. Any other fees to be paid by the Property Representative or vehicle owner or agent shall be enumerated specifically on this agreement, to the extent permitted by law.

**7) Statutes**

The Parties to this Agreement shall be governed by and shall comply with the provisions of Chapters 713.78 and 715.07, Fla. Stat., entitled "Towing of Vehicles."

**8)** By signing of this Agreement, the parties stipulate that they have read and understood the ordinances and statutes listed in paragraph 7 of the Florida State statutes above. Any change, modification to include any towing on hold, or amendment to this contract requires the execution, filing and approval of a new agreement. This must be done by both parties and agreed upon by both parties in its entirety.

By signing this agreement all parties agree to the terms, conditions and fees herein.
